The Sustainability Issues section mentions housing development in Fairford and that there has been no provision to address wider sustainability issues in relation to school and health provision, despite this extensive expansion. Furthermore, it states that with the imminent planning applications for a further c.200+ houses in Fairford it will make matters worse for access to school places and health services (doctor's surgery and hospital).
