Thank you for taking the time to read this leaflet, and for your interest in our plans for Cotswold District Council in 2021/22.

The past year has been incredibly challenging due to Covid-19. I'm extremely proud of the work Council staff have undertaken to support our communities through the pandemic, all whilst continuing to deliver the many services you use.

We've contacted and helped thousands of vulnerable people, we've helped the homeless back into accommodation and increased temporary housing provision, we've supported those affected by flooding and paid out millions of pounds in Government grants to local businesses.

Last year we set a budget that aimed to rebuild the Council's finances after nine years of Government funding cuts. Despite the pandemic, we are making good progress on doing just that so we can continue to improve services and rebuild trust and confidence in Cotswold District Council.

The funding we have still represents a challenge and the money you pay in Council Tax still only covers 15% of our total income.

#### Investing in the Cotswolds during 2021/22

Over the coming year we are looking to invest in the Cotswolds to improve services, protect our environment and help communities bounce back from Covid-19.

£600,000
towards addressing
climate change,
kickstarting our action
plan to make the
Cotswold District
green to the core.

**£740,000**over the next three years towards reviewing our Local Plan to ensure any new development in the District suits the needs of our communities, and protects our landscapes and heritage.

£35,000

each year to continue our fight against flytipping by accelerating education and enforcement. £100,000

over two years to plan and develop better, greener transport options in the District including cycle and walking routes and innovative bus options. £350,000

over three years to fund our Recovery Investment Strategy which aims to make the money we have go further and maximise our support for the District in its recovery from Covid-19.

£25,000

towards championing a review of Open Space, working with housebuilders and residents on good maintenance of public open space on their estates. £23,000

towards helping individuals with complex needs, facing homelessness, to access secure accommodation and support.

£200,000

investment in our Civic Pride Programme over two years, to strengthen our fight against environmental crime and improve the public realm.

## Supporting our communities through Covid-19

Cotswold District Council aims to be proactive and responsive to the needs of its residents and businesses, and to build for the future while respecting the District's heritage.

Our net budget for the 2021/22 financial year is £12.5m. This is funded through your Council Tax, a share of business rates and Government grants.

Only 7.3% of the Council Tax you pay comes to Cotswold District Council. Most of it goes to Gloucestershire County Council and Gloucestershire Police with your local town or parish council receiving the remainder.

The Council consulted on its budget in November and December 2020 for feedback on the proposed budget approach. You can read the responses on our website.

The Cotswold District Council part of this year's Council Tax bill will rise by just 10p a week - the equivalent of £5 a year for the average band D household.
