### PART I GENERAL

#### Commencement and Citation

1. This Order shall come into operation on the  $q^{T^*}$  day of CCOGC-2020 and may be cited as the Cotswold District Council (OFF-STREET PARKING PLACES) (VARIATION) (NO.1) ORDER 2020

#### Interpretation

- 2. In this Variation Order, except where the context otherwise requires, the following expressions have the meanings respectively assigned to them:
  - "the Principal Order" means COTSWOLD DISTRICT COUNCIL (OFF-STREET) PARKING PLACES) ORDER 2018;
- 3. Except where the context requires otherwise, any reference in this Order to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order
- 4. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended, applied, consolidated, re-enacted by or as having effect by virtue of any subsequent enactment

5. The Interpretation Act 1978 shall apply for the interpretation of this Order

#### **PART II**

### Amendment of the Principal Order

6. The First Schedule to the Principal Order shall in relation to the Parking Place numbered 3 (CIRENCESTER, Brewery, Cripps Road) only be amended as follows:

In Column 6 the insertion of the words:

"no return within 1 hour"

- 8. Save as varied by paragraphs 6 and 7 this Order the Principal Order shall continue in full force and effect
