Dear Joseph

Thank you for your consultation on the SEA Screening for the Somerford Keynes Neighbourhood Plan.

My apologies for not responding before now . Your consultation has been followed by the Regulation 14 consultation from the community . We wanted to compare that version of the Plan with the draft provided by you to ensure our assessment was based on the most up to date edition.

I can confirm that we have no objection to the conclusion that the Plan will not require an SEA. I can also confirm that there is little in the content of the Plan which we would feel the need to comment on and we shall be content to leave consideration of matters relating to the historic environment to the discretion of your authority.

We shall reiterate this message in our Reg 14 response to the community. One point we will specifically raise however relates to Community Proposal 6 and the apparent need for a boundary review, updated Appraisal and creation of a Management Plan for the conservation area. We shall suggest to the community that they might like to explore with your authority whether they could take a lead in the necessary exercises – an initiative which we are increasingly finding some other communities doing in the context of their neighbourhood plan activities.
