

COTSWOLD DISTRICT COUNCIL CEMETERY FEES AND CHARGES 2024 - 2025

The following scale of FEES AND CHARGES applicable to CHESTERTON AND STRATTON CEMETERIES, approved by the COTSWOLD DISTRICT COUNCIL, will come into effect as **from 1 April 2024**.

FOR THE INTERMENT, IN A GRAVE (INCLUDING INTERMENT IN A RE-OPENED GRAVE)	
1. of the body of a still-born child or a child whose age at the time of death did not exceed <u>16 years</u>	No Charge
2. of the body of a person whose age at the time of death exceeded 16 years	920.00
3. Extra depth (interment at a depth exceeding 7 feet).	405.00
4. <u>Additional fee</u> for the interment of a coffin/casket exceeding 7ft 2in long or exceeding 32in wide.	385.00

INTERMENT OF CREMATED REMAINS

1. for the interment of cremated remains in a burial garden, a grave or a vault in respect of which an exclusive right of burial has been granted	290.00

INTERMENT OF BODY PART

1. for the interment of a body part in a grave	385.00

The fees indicated above

- (a) include the digging of the grave
- (b) apply when the interment is made within the following hours:-
 - April - September
 - Mondays - Fridays 9.00 a.m. – 3.00 p.m.

 - October - March
 - Mondays - Fridays 9.00 a.m. - 2.00 p.m.
- (c) apply when the interment is made on the certificate of a coroner or registered medical practitioner that immediate interment is necessary.

In any other case an additional fee is payable:

(a) For the interment of a coffin	205.00
(b) For the interment of cremated remains	85.00

EXCLUSIVE RIGHTS OF BURIAL

Exclusive rights of burial are granted for a period of 50 years.

1.	for the exclusive right of burial in an earthen grave 9 x 4 feet: -	1200.00
2.	For the exclusive right of burial in an earthen grave 4½ x 4 feet (grave of a still-born child or a child not exceeding the age of 12 years)	905.00
3.	for the exclusive right of burial of cremated remains in a burial garden	290.00

MEMORIALS AND INSCRIPTIONS

1.	for the right to erect a Memorial on an earthen grave in respect of which the exclusive right of burial has been granted. (This fee includes the first inscription)	530.00
2.	for the right to erect a Memorial on a cremated remains grave in a Burial Garden in respect of which the exclusive right of burial has been granted. (This fee includes the first inscription)	170.00
3.	for each inscription after the first	110.00
4.	Replacement memorials	110.00
