
#### 3.12 Cirencester - Local Green Space Map

The proposed site has residential streets to its east, south and south west boundaries - Bowling Green Avenue, Bowling Green Road, Bowling Green Crescent, Berry Hill Crescent and Berry Hill Road. To the north west of the site there is a working farm, Lower Bowling Green Farm and the Humpty Dumps is currently used for grazing of sheep. There is a footpath through the site and a bridle path that runs along much of the western boundary that is part of the National Trail, The Monarchs Way and part of the recently improved cycleway from the villages of North Cerney and Baunton to Cirencester. The track to Lower Bowling Green Farm is the only vehicular access to the site. Further to the west is Stratton Meadows that run either side of the River Churn, with a wide range of historical footpaths and routes to the adjoining area of Stratton. There has been use of the site by the community of Cirencester since the 1930s for sports and pastimes and use of the site significantly increased in the 1950s with the housing estate development began. Informal pathways as well as the formal footpath and bridleway connect it physically to the surrounding area as a route between the town centre and Stratton.  Visually the site provides a link between residential and the working farm giving Cirencester residents the opportunity to experience the wider agricultural landscape — being able to view livestock and crop growth etc. The Humpty Dumps is part of the local character of the area through its social use — as the name suggests it is very popular during the winter months for snow based activities. Friends of the Humpty Dumps compiled statements from users of the space as part of their pending Village Green application that shows that Cirencester residents take advantage of the sloping site for activities that would not easily be carried out else where such as sledging, mountain bike riding, kite and model aeroplane flying. 



The site is safe and fully enclosed cut off from roads and traffic making it a secure, private, relaxing getaway where you can be surrounded by nature in a semi – wild environment away from the hustle and bustle of daily life. The mix of copse, orchard, open space and bramble with hidden footpaths and clearings makes it an attractive place to be. This is further enhanced by a great variety of songbirds and insects that are present, and the back drop of the attractive cottages of the Victorian Railway Terrace, part of the Kemble Station conservation area. In the early mornings and evenings this is a very peaceful and relaxing place to walk through.  Green	Red	Yes. The Community Gardens are not for playing sport. However, local children often use the site for informal play, the school has an allotment and adults us the site for walking and gardening.  Many dog owners, the elderly people who live in Abbots Way and other roads nearby and families with young children will use the site because it is safe and peaceful. There are two dog bins at either entrance, in the survey 28% of respondents used the gardens for exercise and 19% for walking their dog. Local children prefer to play on the site in natural surroundings where there are no roads. A network of paths and wooded areas enable children to play in safely and use their imagination in a healthy outdoor environment. As it is overlooked by properties on the three sides it is well observed for the security of the children and others. In the survey, 35% said it was place where their children played. The cultivation of the gardens provides fresh vegetables to the gardeners, gives them exercise, brings people together and educates them on gardening matters. Classes from Kemble School use the school plot in the gardens to learn about growing vegetables. All this is recognised as a way to promote wellbeing. The comments in the answers to the survey of Kemble people show that the Gardens are valued for the recreational value and how they are used. 






