A student aged 18 years or over who is resident in the household may entitle you to a discount. If the property is wholly occupied by students the property will be exempt from Council Tax.

Someone qualifies as a student if he or she is:

- On a full-time course of **higher education** i.e. attending a university or college course which lasts for at least an academic year, takes at least 24 weeks a year and involves at least 21 hours of study per week during term-time;
- On a qualifying course of **further education** i.e. under 20 years old, following a course which lasts more than three months and at least 12 hours per week for any qualification up to A level, ONC or OND standard. (Correspondence courses, evening classes, or courses taken up with a person's job, such as day release, are not included);
- Registered as a foreign language assistant with the Central Bureau for Educational Visits and Exchanges. (Overseas students, including a spouse/dependant who is not a UK Citizen and who is prevented from taking paid employment or from claiming benefits, can qualify in the same way as home students.)
