This is the form to be used by a housing benefit and/or council tax support claimant to provide West Oxfordshire District Council's benefits section, with details of self-employed income where an audited statement of accounts for the last financial year.

- The person who is self-employed must complete this form.
- A separate self-employed pro-forma is required for each type of self-employed work.
- Please answer each question, otherwise the form will returned back to you. If a question does not apply to you, please write N/A through the question.
- Where a question does not provide enough space for your answer, continue your answer on a separate sheet of paper. Mark the sheet with your name and question number, and enclose all additional sheets with your completed form.
- Please return your completed form to us straight away.

If you have been self-employed for more than 12 months – you will need to provide details of your actual gross income and gross expenditure for 12 complete calendar months immediately proceeding the date your claim for Housing Benefit and/or Council Tax Support was made. For example, if you were completing the form in November 2013, the 12 complete calendar months would be from 1 November 2012 to 31 October 2013.

If you have been self-employed for less than 12 months – you will need to provide details of your actual gross income and gross expenditure for as many complete calendar months from the date the self-employed work commenced up until the date immediately preceding the date your claim for Housing Benefit and/or Council Tax Support was made. For example, self-employment commenced on 21 January 2013 benefit claim made on the 3 September 2013, details of actual gross income and expenditure required from the 1 February to 31 August 2013 i.e. 7 complete calendar months.

Where your self-employed work has just started, you will need to provide details of your gross income and gross expenditure for how many months you have been trading. For example, self-employment commenced in the last 3 months, details gross income and expenditure required from the start date to the end of the initial 3 months i.e. 3 complete calendar months.

If you have just commenced self employed work in the past few weeks please provide an estimate of what you think your gross income will be for the first 3 months. After which we will send another form for your actual figures.

You must be registered with HMRC before we can consider assessment of your self employed income and provide your reference number.
